FIRST AID

USE RESTRICTIONS: This product may be used on ornamental plantings, shrubs, trees and orchards to help deter feeding deer. DO NOT SPRAY THIS PRODUCT ON FRUITS OR VEGETABLES OR ANY PLANT USED FOR HUMAN FOOD OR ANIMAL FEED. Because of the wide variety of plants and test conditions that may be encountered, test product for phototoxic effects on small areas of plant to be treated before determining whether to treat entire plant or plantings. Scoot Products is not responsible for damage to plants.

APPLICATION DIRECTIONS: Point sprayer away from face and towards plant or object to be treated. Position yourself so that you are spraying with the wind. DO NOT SPRAY INTO WIND. Hold sprayer 12 inches from plant or object to be treated. Apply spray until foliage or targeted areas are uniformly wet. Take care not to miss or soak areas excessively. REAPPLY PRODUCT IF NEEDED AT WEEKLY INTERVALS.

STORAGE AND DISPOSAL: **Storage:** Store only in original container in dry place inaccessible to children or pets. **Disposal:** If empty: DO NOT reuse this container. Place in trash or offer for recycling if available. If partly filled: Call you local solid waste agency or 1-800-CLEANUP for disposal instructions. Never place unused product down any indoor or outdoor drain.
