DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

USE RESTRICTIONS: This product may be used to repel eastern moles (*Scalopus aquaticus*), voles, and gophers from lawns, ornamental and turf.

LOCATING MOLES: The presence of moles may be indicated by a network of surface ridges in the turf or by a series of conical mounds of earth pushed up from deep burrows. Treat all areas which show signs of moles' presence.

APPLICATION DIRECTIONS:

Shake container well before using product. Attach garden hose tightly to self-dispensing container. Turn water supply on to full pressure. Spray SCOOT MOLE EVACUATOR over mole-infested areas at a rate of one quart of product per 10,000 sq. ft. (e.g., a 100 ft. by 100 ft. rectangle). Adjust the spray nozzle to "WATER". Continue to spray with water to soak SCOOT MOLE into the soil. Apply SCOOT MOLE immediately after the presence of moles is detected or in early Spring, mid-summer, and early Fall if there are moles nearby but not on your property.

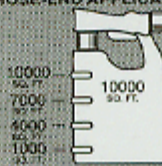

PRODUCT DISPOSAL:

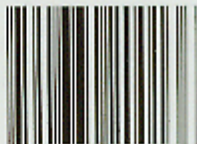
