Target pests include: pigeons, crows, sparrows, starlings, seagulls, grackles, cormorants, vultures, etc.; also rodents and other small critters.

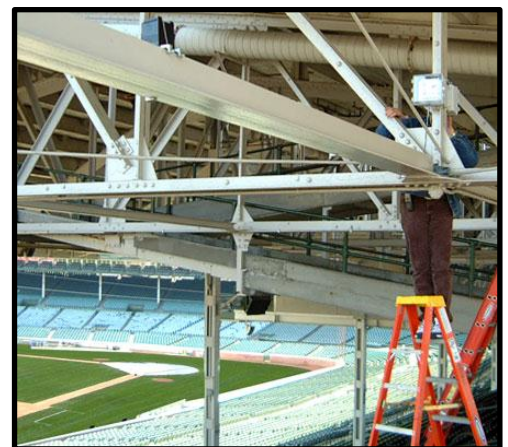
